BASIC NEEDS - GENERAL

1. <u>Human Services Launches Emergency Assistance Program to Help Low-Income</u> <u>Families Amidst COVID-19</u>

May 8, 2020

Department of Human Services (DHS) Secretary Teresa Miller today announced an Emergency Assistance Program (EAP) to help low-income families who lost wages experiencing financial challenges due to the COVID-19 pandemic. Families who qualify will be eligible for a one-time payment to assist them in meeting basic needs and help them secure more stable financial footing in the future.

- 2. Financial Assistance from the Hamer Foundation (through Centre County United Way): Funds are available to help people who are facing financial struggles as a result of the COVID-19 pandemic. The goal is to help them achieve financial stability during this health crisis. Funds must be requested by a qualified non-profit organization. The maximum amount of funds that be requested for an individual/family is \$1,000.00 These funds can support, but are not limited to, the following financial assistance needs:
 - Rent & mortgage payments
 - Hotel/Motel (for emergency shelter)
 - Food
 - Utility bills
 - Medication costs
 - Childcare

Individuals in need must call Centre Helps at (814) 237-5855. Centre Helps will either qualify the individual or refer them to another nonprofit organization.

3. LIHEAP Recovery Crisis Program

LIHEAP Recovery Crisis benefits may be available if a household:

- Has their main or secondary energy source completely shut-off;
- Is notified that their utility service will be shut off in the next 60 days;
- Has broken energy equipment or leaking lines that must be fixed or replace; or,
- Is in danger of being without fuel in 15 days or less.
- Owes funds to a utility provider that would constitute a service termination if not for the Public Utility Commission's moratorium on terminations.

LIHEAP Recovery Crisis program will open on May 18, 2020, and run through August 31, 2020, or until all budgeted funding is expended. The LIHEAP Recovery Crisis maximum benefit will be \$800 for this period. Eligibility guidelines will be the same as those used during the 2019-20 LIHEAP season, and DHS will permit a file transfer agreement with utility providers to allow a utility to submit a LIHEAP Recovery Crisis application on behalf of a consenting household, provided the household has already received LIHEAP Cash to the utility during the regular season. Utility terminations are prohibited for the duration of the Governor's disaster declaration, but past due balances can be submitted as proof of Recovery Crisis eligibility if the utility company confirms that the balance would result in a termination if the moratorium was not in place.

DHS will also automatically issue a \$100 supplemental payment to approximately 100,000 households that received LIHEAP Crisis funds during the 2019-20 season. Any household that has not reached the maximum benefit in the 2019-20 season can apply for additional assistance up to the \$800 maximum limit.

1. Wolf Administration Receives Approval to Launch Food Access Program for Students During COVID-19 Crisis

May 7, 2020

The Wolf Administration received approval from the Food and Nutrition Service of the U.S. Department of Agriculture (USDA) for a plan to provide Supplemental Nutrition Assistance Program (SNAP) benefits to students who are eligible to receive free or reduced-price meals at school through the National School Lunch Program. This program, known as Pandemic Electronic Benefit Transfer (P-EBT), will be temporary and is designed to bridge the gap left by schools closing and help families who may have strained resources due to the COVID-19 pandemic.

2. No One Should Go Hungry, Pennsylvanians Should Apply for Programs Designed for 'Times Like These'

First Lady Frances Wolf, Department of Human Services Secretary Teresa Miller, and Department of Agriculture Secretary Russell Redding today outlined food assistance programs available for Pennsylvanians to enroll in to get them through current COVID-19-induced tough times. They said Pennsylvanians should feel no shame in accepting state and federal food benefits that were, in fact, designed for unprecedented times like the coronavirus pandemic.

While most eligibility verifications for food assistance have been waived to reduce barriers to access during COVID-19 mitigation in Pennsylvania, there are several state programs that still require individuals to seek out and enroll in individually to qualify and receive benefit. These programs include:

- Supplemental Nutrition Assistance Program (SNAP): Formerly known as food stamps, SNAP provides assistance to low-income and working Pennsylvanians, allowing them to purchase produce and groceries for themselves and their family. SNAP helps more than 1.8 million Pennsylvanians, including about 700,000 children, about 690,000 people with disabilities, and about 300,000 older adults, expand purchasing power to ensure their household has enough food to avoid going hungry. SNAP is issued through a monthly payment to an electronic benefit transfer card, and benefits are based off income and household size. People can apply for SNAP online at www.compass.state.pa.us online at any time.
- Senior Farmers Market Nutrition Program: This program runs from June 1 through November 30 each year. Seniors must be 60 or older by December 31 of the program year and have income at or below 185% of the U.S. poverty level. Eligible seniors should call their county Aging office for information on distribution of vouchers. Vouchers are distributed on a first come, first serve basis.

- <u>WIC Farmers Market Nutrition Program</u>: This program runs from June 1 through November 30 each year, and recipients must be on the WIC program to receive this benefit. Children 1-year and older, and pregnant/post-partum women will receive vouchers for the program during their quarterly WIC visit (May through September).
- <u>Commodity Supplemental Food Program</u>: Eligible participants include individuals who are at least 60 years old and whose household income is at or below 130% of the U.S. poverty level. To qualify, individuals must complete an application with proof of income. Questions about where/how to access this program can be directed to the Department of Agriculture's Bureau of Food Assistance by calling 1-800-468-2433 or emailing ra-fooddist@pa.gov.
- Special Supplemental Nutrition Program for Women, Infants, and Children (WIC): Women who are pregnant or have had a baby in the past six months, or twelve if breastfeeding; infants and children under the age of five; and fathers, grandparents, and foster parents who are the legal guardian of a child under age five, may apply for WIC. WIC applicants must reside in Pennsylvania, have a medical or nutritional risk, and have a gross household income that does not exceed 185% of the U.S. poverty level.

In addition to applying for the benefits above, Pennsylvanians can receive immediate access to food resources by visiting a Feeding Pennsylvania or Hunger-Free Pennsylvania member food bank. Pennsylvanians out of work and without pay as a result of COVID-19 are eligible to receive state and federally sourced foods from Pennsylvania's food banks and pantries

(May 1st, 2020): **The YMCA Anti-Hunger Program (home delivery)** is announcing today that we will be providing Home Delivery for families and Shut-Ins that don't have the means to get to our feeding sites or Food Giveaways, This is a major undertaking that will have an impact on those that are facing food insecurity This service will be available starting the week of May 4th. This system will tracked through and planned in a GIS Program to make sure we are efficient in delivering food to all residents that have contacted us. - 5. (Coming Soon!) Online Purchasing for SNAP Participants (Pilot Program): DHS is working with its EBT vender and approved retailers to implement only payment for PA's SNAP recipients. It is expected that online grocery purchasing will be activated for SNAP participants by the <u>beginning of June</u>. Once active, only eligible food items normally paid for by SNAP will be able to be purchased online with SNAP benefits. Delivery feeds, driver tips, and other associated changes may not be paid for with SNAP benefits. This pilot program includes three approved retailers: Amazon, Walmart, and ShopRite.
- 6. Senior 2020 Farmer's Market Vouchers: Applications can be completed and mailed back to the Office of Aging; they cannot be completed in-person this year. Farmer's Market vouchers will then be mailed out to all eligible seniors who applied. Please see Attachment B, and Attachment C for the application and additional program information.
- 7. Calvary Church Free Food Distribution: Weekly box of dried goods, fruits, veggies, eggs, milk, and meat. No eligibility criteria! Everyone is welcome! Pick up OR delivery. In order to get a box of food, please email Kendra Gettig at Kendra@calvarysc.org or call/text at 814.571.8293

HOUSING

1. Governor Wolf and Attorney General Shapiro Announce Protections from Foreclosures and Evictions Through July 10

Governor Tom Wolf was joined by Attorney General Josh Shapiro today to announce that he signed an <u>executive order</u> that protects Pennsylvanians from foreclosures or evictions through July 10. The action builds on a Pennsylvania Supreme Court order which closed court eviction proceedings until May 11 and ensures no renter or homeowner will be removed from their home for 60 more days.

In almost all circumstances, renters and homeowners are required to continue making monthly payments. If you are a Pennsylvanian struggling to make your monthly payments, you should contact your landlord or mortgage servicer immediately.

The Wolf Administration provided <u>recommendations</u> last week to stem foreclosures, evictions and help people experiencing homelessness. The Department of Human Services activated the commonwealth's Sheltering Taskforce and is working with local and state partners to coordinate resources for people without housing. The Department of Community and Economic Development is also accepting applications for <u>Emergency Solutions Grants</u> to assist with the rapid rehousing of people experiencing homelessness, street outreach, homelessness prevention, and emergency shelter activities.

PHFA is also taking action to help homeowners and renters. The agency has stopped foreclosures and evictions and is offering forbearances with late fee waivers to homeowners with a PHFA mortgage who are experiencing a financial hardship because of COVID-19. PHFA also developed a list of <u>renters' rights and responsibilities</u> to clarify the situation for apartment residents and is working with landlords and property managers to distribute it to renters. PHFA is also encouraging Low-Income Housing Tax Credit building managers to be flexible on rent payments and to waive late fees for tenants whose employment has been affected by the crisis.

2. Rent Rebates to arrive early for seniors and people with disabilities

Governor Tom Wolf and Treasurer Joe Torsella today announced that many older homeowners, renters and people with disabilities will receive early rebates through the Property Tax/Rent Rebate Program. Rebates are typically issued starting July 1, but the governor and treasurer are issuing the rebates starting tomorrow to approved applicants. The governor also signed HB 1076 today, which authorizes the early distribution.

The distribution of rebates by the Department of Revenue and Treasury is different than prior years. Rather than a large distribution of rebates on July 1, rebates will be processed and distributed on a first-in-first-out basis. This gradual process means some claimants will receive their rebates earlier than others.

For eligible applicants who have yet to file their Property Tax/Rent Rebate Program application, the Department of Revenue is offering help for those who need it. Eligible claimants are encouraged to call 1-888-222-9190 for guidance. Please keep in mind that department staff will work as quickly as possible to help claimants with their applications.

Applicants are encouraged to obtain the Property Tax/Rent Rebate claim form (PA-1000) and related information on the <u>Department of Revenue's website</u>.

The deadline for older adults and Pennsylvania residents with disabilities to apply for rebates on rent and property taxes paid in 2019 was <u>extended from June 30 to Dec. 31</u>, 2020.

3. 2020 PA CARES Rent Relief Program

Any resident or landlord (on behalf of their tenant) who is interested in this program should visit: http://phfa.org/pacares to review eligibility criteria and complete an application for assistance. This website will be live effective Monday, June 29th, 2020. The CARES RRP will officially open on Monday, July 6th, 2020.

For Centre County renters to be eligible for financial assistance under the CARES RRP, they will need to document at least a 30% reduction in annual income since March 1st, 2020 OR they must have become unemployed after March 1st, 2020 as a result of the COVID-19 pandemic. If unemployed, they must have filed for unemployment compensation with the Pennsylvania Department of Labor and Industry. Their household income cannot exceed Centre County's Area Median Income (AMI), adjusted for the number of people in their home. Renters who qualify may receive assistance equal to 100% of their monthly rent up to \$750/month, for a maximum of 6 months, for the time period between March 1st, 2020 and December 30th, 2020. This program is scheduled to open on Monday, July 6th, 2020.

EMPLOYMENT

1. Pennsylvania Launches COVID-19 Job Hiring Portal

The Department of Labor and Industry has launched a new <u>online job portal</u>. People seeking employment can visit <u>www.PAcareerlink.pa.gov</u> and select the green "PA COVID-19 Jobs – Hiring Immediately" job portal banner to see active job openings. Selecting the "Apply Now" button for a listed position will redirect individuals to the employer's website or email where they can apply directly with the employer and speed up the hiring process.

Life-sustaining businesses can feature their job openings on the portal through an easy to use online form. Businesses must meet the criteria of a life-sustaining business and must have more than 10 job openings .

The PA COVID-19 job portal is updated daily so businesses in need are spotlighted and people searching for employment have the latest job information

FMNP and SFMNP Basic Rules and Regulations

- FMNP checks cannot be used before June 1, 2020 or after November 30, 2020.
- FMNP customers may buy only the fruits and vegetables grown in Pennsylvania
- Recipients must sign in the "Signature Recipient or Proxy" block on the front of the checks. Do this before going to the market or take a pen with you.
- At the market look for stands displaying the white Farmers Market Nutrition Program poster.
- Each check is worth \$6. Farmers are <u>not</u> permitted to give change for purchases for less than \$6.
- Program recipients may place orders online with FMNP approved farmer; however, you must pay with your paper FMNP checks. A proxy may go to markets to make the purchase for you.
